The Paperwork Reduction Act of 1995 requires us to inform you that the Minerals Management Service (MMS) collects this information to document fulfillment of royalty obligations and sales of minerals from leases on Federal lands. We will use this information to evaluate bids for sale of royalty production. Proprietary information is protected in accordance with standards established by the Federal Oil and Gas Royalty Management Act of 1982 (30 U.S.C. 1733), the Freedom of Information Act (5 U.S., 552 (b)(4)), and the Departmental Regulations (43 CFR 2). Responses are required to obtain a benefit. COVER PAGE

The Minerals Management Service (MMS) is soliciting applications from qualified energy companies and organizations to be placed on a list of potential purchasers of the royalty portion of natural gas produced from nearshore leases off the coast of Texas.

This solicitation consists of this Cover Page and the attached Requestor's Signature Page.

The royalty gas will be sold by MMS as part of its royalty in kind (RIK) pilot programs designed to test the feasibility of the RIK concept. The Texas RIK pilot project is a joint initiative of MMS and the State of Texas General Land Office (GLO) in which natural gas from Outer Continental Shelf properties known as 8(g) leases will be sold to Federal end user customers and also to the public through competitive bidding.

This solicitation is the first step in the process to sell royalty gas in the MMS/GLO RIK pilot to the public by competitive bidding. Energy companies or organizations that respond to this request and are deemed qualified by MMS to purchase royalty gas will be notified and asked to competitively bid for the purchase of specific volumes of royalty gas when they become available. Future notification of sales of individual gas packages will occur during the bid week immediately preceding the month of initial sales. The contract period may be 1 month, 6 months, 1 year, or 2 years, as specified in each notification of sale. Potential purchasers will submit bids by methods and to points of contact specified in each notification of sale. Delivery points will typically be major pipeline interconnects, hubs, or gas plants onshore in Texas.

Qualified potential purchasers that successfully bid for purchase of royalty gas in future sales may be required to post a letter of credit, corporate guarantee, or other form of surety, based upon MMS analysis of financial soundness of potential purchasers.

The application process to become prequalified for potential purchase of royalty gas in this RIK pilot program will be ongoing, i.e., there is no deadline for application. The MMS will keep the list of prequalified potential purchasers of royalty gas active through the end of the year 2000, at which time a new prequalification process will be conducted to update the list.

Potential purchasers of Federal gas in this RIK pilot program must certify that the company's total revenues from buying and selling natural gas have not been less than \$15,000,000 (U.S. dollars) during any calendar year from 1994 through 1998. MMS requests that interested energy companies or organizations complete and send the attached Requestor's Signature Page with the most current company Financial Statement to:
